NOTE 1 In commercial reports, the extraordinary expenses incurred will also be charged if, for urgent reasons, the telephone, telegraph, fax, information agencies or special services of the Bank's advisers are used.

When the Property Registry is consulted on behalf of third parties, in addition to the aforementioned fee, any accrued expenses and expenses incurred will be charged.

NOTE 2 Miscellaneous Banking Transactions refers to typical banking processes carried out before Public or Private Bodies on instructions from the customer, and whose common characteristic is the necessary travel of the Bank's staff, often of authorized representatives. This fee cannot be applied if the transfer is for the purpose of signing a deed or is necessary to improve the operation, and in cases where the entity assumes a contractual obligation.

The following are provided as examples:

Deposits, Bonds and Guarantees to ensure the execution of works and credits. Record of endorsements.

Payment request made by Notaries involving disputed and endorsed effects.

NOTE 3 When picking up funds on-site for more than 6,010.12 euros, the use of specialized companies in armored vehicles is required. This service is billed to the petitioner, unless otherwise agreed.

NOTE 4 This fee will accrue when the customer requests the study, advice and issuance of a report, and is received once when the written report is delivered to the customer. If a preliminary report is issued and a savings capitalization product, insurance policy or pension plan is subsequently procured within a reasonable time frame, this fee will be waived, or it will be returned to the customer if already charged.

NOTE 5 The indirect taxes in effect in each territory will be payable by the customer. Balance 0 certificates, capital contributions and those issued in compliance with regulatory requirements, exempt. Assisted channels refer to branches, BBVA Contigo, and telephone banking. Remote banking, transactional websites and the BBVA app.

NOTE 6 The percentage charged will be applied to the amount of the tax to be refunded.

NOTE 7 Postage expenses will be charged for each shipment.

NOTE 8 The VAT (or relevant tax in the Canary Islands, Ceuta and Melilla) in effect during the accrual period will be added to the amount of this fee.

NOTE 9 The process of managing, obtaining or renewing non-resident or resident certificates in Spain will be carried out if expressly requested by the customer.

NOTE 10 The aforementioned fee will be charged to the customer for each vehicle documentation that is processed through BBVA.

NOTE 11 Except for the payment of taxes and fees.

NOTE 12 The VAT in effect during the accrual period will be added to the amount of this fee.
