BBVA Más Salud promotion

Promotion applicable to new insured parties in new policies, in all BBVA channels, of BBVA Más Salud products (BBVA Más Salud without co-payment, BBVA Más Salud with co-payment and BBVA Más Salud Esencial) and BBVA Salud Autónomos (BBVA Salud Autónomos without co-payment, BBVA Salud Autónomos with co-payment and BBVA Salud Autónomos Esencial), for BBVA customers (not BBVA Group employees), **for policies underwritten from March 28, 2022, and with an effective date in April, May and June 2022.**
